Glossary

- Participating entity: Any national government entity, national association of municipality, development agency, non-governmental organizations (NGO), civil society organizations (CSO), academia and research institution, private sector organization, UN entity or organization, networks or interested entities with specific knowledge and expertise that can support cities to progress along the resilience roadmap are encouraged to join and support local governments in making cities resilient. The following three categories of entities are involved with the MCR2030:
 - 'Core Partners' or Members of the Global Coordinating Committee of the MCR2030: include C40 Cities, ICLEI – Local Government for Sustainability, International Federation of Red Cross and Red Crescent Societies (IFRC), Japan International Cooperation Agency (JICA), Resilient Cities Network (R-Cities), United Cities and Local Governments (UCLG), United Nations Human Settlements Programme (UN-HABITAT), United Nations Office for Disaster Risk Reduction (UNDRR), United



Nations Office for Project Services (UNOPS), The World Bank Group, and World Council on City Data (WCCD) serving as the Global Coordinating Committee of MCR2030 and providing a strategic guidance to the implementation of MCR2030.

- 'Supporting Entities' or Gratis technical expertise-providing entities are noncommercial entities with expertise in specialized areas in the regions that have mandates or activities aligned with MCR2030 and can provide specific gratis technical inputs in fields that support cities to move through the 12 thematic areas in support of MCR2030 and along the resilience roadmap. This includes national government development agencies, non-governmental organizations (NGOs), civil society organizations (CSOs), academia and research institutions, media, as well as national governments, national associations of municipalities, and others. These entities are able to provide gratis services as part of their in-kind contribution to MCR2030 cities.
- **Specialist Service Providers (SSPs)** are the entities, including but not limited to the private sector, that can offer technical one-to-one advice and support cities in the formulation and implementation of the resilience actions. SSPs may charge a fee for their services and are expected to be engaged by the cities and local governments through the cities or local government's procurement processes. Such arrangements are to be entered into by the recipient cities and the service providers directly and are independent of MCR2030. Members of the Global Coordinating Committee of the MCR2030, gratis technical expertise-providing entities and any entities or individuals serving on the advisory bodies of UNDRR cannot be specialist service providers as this would pose a conflict of interest.
- Dashboard: MCR2030 dashboard is a <u>closed</u> online workspace only accessible by cities participating in the MCR2030 and participating entities (organizations) who want to provide tools, knowledge products, technical assistance and consultancy services that can help local governments improves resilience. The MCR2030 dashboard displays these services in a directory, similar to yellow-pages, in which a city can view a catalogue of services, and look for a potential partner or service provider to support their work in disaster risk reduction and resilience building. Some services may be free of charge, while some services may involve fees and entail transaction agreements. Cities can browse the information about the service and decide to contact partners/service providers to further understand each other's needs, the requirements, terms and conditions for services, including local procurement procedures.
- **Service:** Something that an organization can offer to cities, related to DRR and resilience. For example, training, workshop, a grant, consulting services, tools and methodologies,



etc. All services must contribute to at least one of the 12 thematic areas of support provided under MCR2030.

- MCR2030 thematic areas of support: Thematic areas of support under MCR2030 are divided into 12 categories, spreading across the three stages of resilience roadmap.
 - 1) Awareness raising on DRR and resilience (Stage A)
 - 2) Improving risk analysis (Stage B)
 - 3) Improving diagnostic skills for planning (Stage B)
 - 4) Improving strategies and plans (Stage B)
 - 5) Increasing access to finance (Stage C)
 - 6) Ensuring resilient infrastructure (Stage C)
 - 7) Adopting nature-based solutions (Stage C)
 - 8) Integrating climate risk into strategies and plans (Stage C)
 - 9) Ensuring inclusion (Stage C)
 - 10)Enabling national-local linkages (Vertical Links)(Cross-cutting)
 - 11)Strengthening partnership within the city (Horizontal Links)(Cross-cutting)
 - 12)Promoting city-to-city learning (Cross-cutting)
- PreventionWeb account: The username and password you need to have in order to sign-up and log in to the MCR2030 dashboard. You can also use it on <u>preventionweb.net</u>, to access other UNDRR web services.

Which entity is eligible to participate in MCR2030?

Any national government entity, national association of municipality, development agency, non-governmental organizations (NGO), civil society organizations (CSO), academia and research institution, private sector organization, UN entity or organization, networks or interested entities with specific knowledge and expertise that can support cities to progress along the resilience roadmap are encouraged to join and support local governments in making cities resilient.

Such entity must:

- 1. Be a legal (i.e., incorporated) entity in the country or territory,
- 2. Be willing to undertake one of the three roles of participating entities (Core Partner, Supporting Entity or Special Service Providers), and
- 3. Be willing to take action contributing to achieve the Sustainable Development Goals, the priorities of the Sendai Framework for DRR, New Urban Agenda, the Paris Agreement.

Additionally, the entities must self-declare the below when applying:



- 1. The Entity does not appear on the United Nations Security Council Consolidated Sanctions List or the United Nations Vendor Ineligibility List, and is not in violation of UN sanctions, relevant conventions, treaties and resolutions;
- 2. The Entity does not have any direct and core involvement in the manufacturing or trading of weapons subject to bans under international treaties, including the sale, manufacture or distribution of weapons banned by UN treaties, such as antipersonnel mines, cluster bombs and ammunitions, and biological, chemical, or nuclear weapons, for instance;
- 3. The Entity has not been and has no direct involvement or complicity in systematic or egregious human rights abuses through operations, products, or services, including through their own business activities (such as forced or compulsory labor or child labor, human rights violations, illegal mining activities, including rights of indigenous peoples, and/or other vulnerable groups);
- 4. The Entity is not involved in the business of the production and wholesale distribution of tobacco products;
- 5. The Entity has not been convicted of any crimes or offenses;
- 6. The Entity has not been engaging in sexual exploitation and abuse;
- 7. The Entity does not promote or engage in corrupt practices, including bribery and extortion;
- 8. The Entity is in good standing under applicable law.

Any interested entities that have the attributes and be willing to undertake the actions listed above may access the dashboard and directory sign-up, complete the online application process, and complete the self-check list.

What is a sign-up procedure?

There are 3 steps to the sign-up procedure.

- 1) Complete the application process including providing the basic organization profile,
- 2) Complete the organization details, and
- 3) Create the list of services your organization want to provide for MCR2030 cities.



How to sign-up and create an organization profile on the dashboard?

1. Visit the MCR2030 dashboard landing page at http://mcr2030dashboard.undrr.org/



- 2. Select '**Participating entity'** from the dropdown.
- 3. Select 'Next'.

- 4. Confirm if anyone from your organization already signed up to MCR2030 on behalf of your organization. (Yes/No)
 - If **'Yes'**, you will not be able to proceed. (If someone from your organization has already signed up, please coordinate with the person to get access to the dashboard. Do not sign up again as this will create a duplicate profile).
 - If **'No'**, continue with next steps.
- 5. Click 'Next'.

- 6. Do you already have a **PreventionWeb account**? When prompted, either **'Login'** if you do, or **'Register Now'** if not.
 - If you have chosen '**Register Now**' and have completed the PreventionWeb account registration, a confirmation link will be sent to your registered email address from PreventionWeb. Check your mailbox and click that confirmation link to continue with sign up to the MCR2030 dashboard. Check your spam mailbox as well.
 - *Tips:* Decide who from your organization will be responsible for managing the organization profile on the MCR2030 dashboard. The person will, by default, have the administrative role for your organization and will be able to add/remove/manage your team members.
- 7. After successfully login to your PreventionWeb account, an Authorization Request window from PreventionWeb will pop up. Select **'Authorize'**, allowing MCR2030 access.

- 8. Fill in the *basic* details of the organization profile that will display to other MCR2030 participants.
 - Please enter details in **English** for easier browsing by cities around the world. You can enter the text in another language in another section.

- 9. After complete all basic information, click 'Proceed to review'.
- 10. Review the details you have entered and check the boxes to agree to all <u>Privacy Policy</u> and <u>Terms and Conditions</u>, and self-declaration.
 - If you want to edit any information, click "Edit my details".
 - If you are ready to proceed, click "Let's Get Ready".

- 12. What's next? Continue to complete your organization profile and list your services for MCR2030 cities by selecting **'Complete organization profile**'.
- 13. Fill in more *details* about your organization.
 - Please try to fill in every field, if possible.

- 14. Click 'Save organization profile'.
- 15. Click 'Return to dashboard' to proceed to the main dashboard page.

How to edit my organization profile?

1. You can update your profile as needed using the **Organization basics** and **Organization details** in the left menu (top menu on mobile and tablet)





How to add a service

- 1. Select 'Add a service' from the left menu.
 - On mobile, tablet, and some small laptops, the menu is in the "hamburger" icon on the top right.



- 2. Fill in the details for the service.
 - Try to fill in every field and provide as much information to help cities understand about your services.
 - You can enter service description in your local language in this page.
- 3. Click 'Publish service' for it to be visible by MCR2030 dashboard users.

Note:

- You can list up to 15 services on the dashboard.
- You can 'hide' your service by sliding the **Hide this service slider** to the right (purple color).





How to edit a service

- 1. Select **'Edit services'** from the left menu.
 - On mobile, tablet, and some small laptops, the menu is in the "hamburger" icon on the top right.



How to add team members

The email used to sign up your organization to MCR2030 will have the Admin role by default. Only Admin can add, delete, and manage your team members.

1. Select 'Add team member' under Manage my team menu on the left.



- 2. Enter your team member's email. Use the same email address your team member uses for PreventionWeb account.
- 3. Select user's role:
 - *Administrator* has access to the dashboard functions and can add/delete/manage team members.
 - *User* has access to the dashboard functions but cannot add/delete/manage team members.

- 4. Click '**Invite team member**'. Your team member will receive an email with the subject 'You have been added as a team member on MCR2030'.
